



## **Parent View User Agreement**

Parent View is provided by Arnold Hill Academy for the use of parents of students attending Arnold Hill Academy. The overall aim of Parent View is to provide further assistance to parents in supporting their child. The purpose of this agreement is to guide the users of Parent View and to protect the rights of all individuals including the safety and well-being of all students.

**'By using the Parent View you will be agreeing to uphold the terms of this Agreement'.**

Parent View

**"Parent View"** includes Parent View, VLE, School Website and other Internet sites on which these terms of use are posted. Arnold Hill Academy and all entities that control, are controlled by, or are affiliated or under common control with Arnold Hill Academy are collectively referred to herein as **"we," "us" or "our"**.

**"Users"** refers to all other persons that access the Parent View and its related sites, including the parent, student, staff and governors of Arnold Hill Academy.

Accounts

You are required to have a valid account to access the Parent View. You agree to provide, maintain and update true, accurate, current and complete information about yourself as requested by our registration processes. You shall not impersonate any person or entity or misrepresent your identity or affiliation with any person or entity, including using another person's username, password or other account information, or another person's name, likeness, voice, image or photograph.

You also agree to notify us promptly at [slg@arnoldhillacademy.co.uk](mailto:slg@arnoldhillacademy.co.uk) of any unauthorised use of your username, password, other account information, or any other breach of security that you become aware of involving or relating to Parent View.

We may suspend or terminate your account and your ability to use any Parent View site or feature for failure to comply with these terms of use or any special terms relating to a particular service, for infringing copyright, or for any other reason whatsoever.

Use of Content

Unless as we specifically agree in writing, no content from the Parent View may be used, reproduced, transmitted, distributed or otherwise exploited in any way other than as part of the Parent View, except that where the Parent View is configured to enable the download of particular content.

You may download one copy of such content to a single computer for your personal, non-commercial home use only, provided that you (a) keep intact all copyright and other proprietary notices, (b) make no modifications to the content, and (c) do not use the content in a manner that suggests an association with Arnold Hill Academy. Any business use, "**re-mailing**" or high-volume or automated use of the Parent View is prohibited. In the event that we offer downloads of software on Parent View and you download such software, the software, including any files, images incorporated in or generated by the software, and data accompanying the software (collectively, the "**Software**") are licensed to you by us or third-party licensors for your personal, non-commercial home use only. **We do not transfer title to the Software to you.** You may not distribute or otherwise exploit the Software or decompile, reverse engineer, disassemble or otherwise reduce the Software to a human-readable form.

#### Public Forums and Communication

"**Public Forum**" means an area, site or feature offered as part of Parent View that offers the opportunity for users to contribute submissions including chat, message boards, instant messaging, social community environments, profiles, blogs and email.

You acknowledge that contributions/submissions to any Public Forum are publically accessible to all users of Parent View and you have no expectation of privacy with regard to any submission to a Public Forum.

You are and shall remain solely responsible for the submissions you distribute on or through Parent View under your username or otherwise by you in any Public Forum. Whilst we will make every effort to monitor the Public Forum, we cannot be held responsible for doing so.

#### Submissions

In these terms of use, we use the word "**Submissions**" to mean text, messages, ideas, suggestions, photographs, and/or other similar materials that you submit, post, upload, display, communicate or otherwise distribute (collectively known as "**Distribute**") on or through Parent View.

There are two types of Submissions: Solicited Submissions and Unsolicited Submissions. "**Solicited Submissions**" means those Submissions (a) that we expressly request or enable you to provide to us via any feature or activity on Parent View for our review or display, e.g. a survey. "**Unsolicited Submissions**" are any and all Submissions that do not fall within this above category. By signing this document you agree to not distribute any unsolicited submissions. Submissions may be used and disclosed by us if necessary.

#### Removal of Submissions

We reserve the right, but disclaim any obligation or responsibility, to (a) refuse to post or communicate or remove any Submission from the Parent View that violates these terms of use and (b) identify any user to third parties, and/or disclose to third parties any Submission or personally identifiable information, when we believe in good faith that such identification or disclosure will either (i) facilitate compliance with laws, including, for example, compliance with a court order, or (ii) help to enforce these terms of use and/or protect the safety or security of any person or property, including Parent View. Moreover, we retain all rights to remove Submissions at any time.

## Code of Conduct

The following Rules of Conduct apply to Parent View. By using Parent View, you agree that you will not distribute or contribute any submission that:

- a) is defamatory, abusive, harassing, threatening, or an invasion of a right of privacy of another person;
- b) is bigoted, hateful, or racially or otherwise offensive;
- c) is violent, vulgar, obscene, pornographic or otherwise sexually explicit;
- d) otherwise harms or can reasonably be expected to harm any person or entity;
- e) is illegal or encourages or advocates illegal activity or the discussion of illegal activities with the intent to commit them, including a Submission that is, or represents an attempt to engage in, child pornography, stalking, sexual assault, fraud, trafficking in obscene or stolen material, drug dealing and/or drug abuse, harassment, theft, or conspiracy to commit any criminal activity;
- f) infringes or violates any right of a third party including: (a) copyright, patent, trademark, trade secret or other proprietary or contractual rights; (b) right of privacy; or (c) any confidentiality obligation;
- g) is commercial, business-related or advertises or offers to sell any products, services or otherwise;
- h) contains a virus or other harmful component, or otherwise tampers with, impairs or damages Parent View or any connected network, or otherwise interferes with any person or entity's use of Parent View; or does not generally pertain to the designated topic or theme of the relevant Public Forum; violates any specific restrictions applicable to a Public Forum, including its age restrictions and procedures; or is antisocial, disruptive, or destructive, including "flaming," "spamming," and "flooding," as those terms are commonly understood and used on the Internet.
