30 JUNE AT 18:00	UCAS Undergraduate applications received after 30 June are entered into Clearing.
JULY ONWARDS	Unreformed Pearson BTEC results available on a rolling basis from July.
4 JULY	Last day for applicants to add an Extra choice in Track.
5 JULY	Publication of International Baccalaureate results.
5 JULY ONWARDS	<ul style="list-style-type: none"> > Clearing opens and vacancies are displayed in our search tool. > Clearing numbers automatically show in Track for eligible applicants. > Applicants holding a place can release themselves into Clearing, using the 'Decline my place' button in Track.
27 JULY	The last Applicant Status Report (ASR) before SQA and A level results is available to download in Adviser Track .

31 AUGUST	Adjustment closes.
1 SEPTEMBER	First Final Destination Report (FDR) updated, and available to download in Adviser Track 2019.
20 SEPTEMBER AT 18:00	Last date for receipt of 2019 entry UCAS Undergraduate applications.
21 SEPTEMBER	Second Final Destination Report (FDR) updated, and available to download in Adviser Track 2019.
30 SEPTEMBER	Clearing vacancy information closes.
5 OCTOBER	Third Final Destination Report updated, and available to download in Adviser Track 2019 by 31 October.
22 OCTOBER	Last date to add Clearing choices in Track, and for unis/colleges to make decisions.
31 OCTOBER	Apply for Adviser 2019 entry closes and will be decommissioned – you will no longer have access to your 2019 applications or your Final Destination Report.
